When you send us e-mail from this Web site, you will. Provide us with certain personally identifiable information including your e-mail address.

Cookies

A cookie is a piece of data that is stored on a visitor's hard drive while they are visiting this Web site. We may utilize a short-lived form of cookie when you visit this site. At ISU. Insurance Services. The Webb Agency, a cookie is only used to

identify one unique visitor from another visitor during a particular session. A session is the period of active site-use while that unique visit is linked to our server.
